This Certificate of Merger is being filed by the undersigned in the Office of the Secretary of State of the State of Georgia in accordance with the provisions of Section 14-2-1104 and Section 14-2-1105 of the Georgia Business Corporation Code (the "GBCC") in order to merge BlueLinx Services Inc., a Georgia corporation (the "Subsidiary"), with and into BlueLinx Corporation, a Georgia corporation ("Parent" or the "Surviving Corporation"), which shall be the surviving corporation (the "Merger").

FIRST: This Certificate of Merger, and the Merger, shall become effective at 11:59 p.m. Eastern Standard Time on December 31, 2014 (the "Effective Time").

SECOND: The name and state of incorporation of each of the constituent corporations to the Merger are as follows:

THIRD: The name of the Surviving Corporation in the Merger is BlueLinx Corporation.

FOURTH: At the Effective Time, the Articles of Incorporation of Parent as in effect immediately prior to the Effective Time shall be the Articles of Incorporation of the Surviving Corporation.

FIFTH: The executed Plan of Merger is on file at the principal place of business of the Surviving Corporation, the address of which is 4300 Wildwood Parkway, Atlanta, Georgia 30339.

SIXTH: A copy of the Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of any corporation that is party to the Merger.

SEVENTH: Pursuant to Section 14-2-1103(h) of the GBCC, the approval of the shareholders of the Surviving Corporation is not required. Pursuant to Section 14-2-1104(s) of the GBCC, the approval of the Parent, in its capacity as the sole shareholder of the Subsidiary, is not required.

EIGHTH: A request for publication of a notice of filing this Certificate of Merger, and payment therefore, will be made as required by Section 14-2-1105.1(b) of the GBCC.
