RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECOND LIEN TRADEMARK SECURITY

AGREEMENT (this "Release") is made as of December 5, 2014 ("Effective Date") by and between Wilmington Trust, National Association, in its capacity as Collateral Agent ("Collateral Agent"), in favor of Taminco NV, a Belgian company ("Grantor").

WHEREAS, Grantor and Collateral Agent entered into the Second Lien Trademark Security Agreement pursuant to the terms and conditions of (a) the indenture dated as of February 3, 2012 (as amended, supplemented, extended, refinanced or otherwise modified from time to time, the "Indenture"), among Taminco Global Chemical Corporation as issuer, the guarantors from time to time party thereto and the Collateral Agent and (b) the Second Lien Collateral Agreement dated as of February 15, 2012 (as amended, supplemented, or otherwise modified from time to time, the "Collateral Agreement"), among Holdings, the Issuer, the other grantors from time to time party thereto and the Collateral Agent;

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on February 15, 2012, at Reel 4718, Frame 0691; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Collateral Agent under the (a) Indenture and (b) Collateral Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Second Lien Trademark Security Agreement, and hereby terminates, discharges, cancels and releases any and all security interests it has against the Trademark Collateral.

Collateral Agent shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested in writing by Grantor to more fully and effectively effectuate the purposes of this Release.
