

I, JOHN HUFF, state as follows:


1. I have personal knowledge of the facts in this affidavit.
2. I am the Manager and Chief Executive Officer of PurUSHealth, LLC ("PurUS"), an Ohio limited liability company.
3. On or about February 27, 2014, PurUS executed a Cognovit Promissory Note (the "Note") in the amount of Four Hundred Thousand Dollars (\$400,000) in favor of Scot Cohen ("Cohen") and an Intellectual Property Security Agreement granting Cohen a security interest in all of PurUS's existing and future intellectual property, including patents, trademarks, copyrights, and any applications therefor, or proceeds thereof (the "Security Interest") until the full amount of the Note is paid.
4. The Security Interest was recorded by the Trademark Office as Assignment Number 900282196 on March 6, 2014.
5. The Security Interest was recorded against two (2) PurUS properties: Registration Number 4119774, Work mark: "GOOD GREENS"; and Serial Number 85270812, Word mark: "Z52".
6. On July 30, 2014, PurUS paid to Cohen the full amount due under the Note by wire transfer, as evidenced by the bank statement excerpt attached as Exhibit A.
7. By virtue of full payment on the Note having been made and accepted, the Security Interest was thereby extinguished on July 30, 2014.
