



Verso Paper Corp. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies that:

**FIRST:** The name of the Corporation is Verso Paper Corp.

**SECOND:** The original Certificate of Incorporation of the Corporation, then named CMP One Corp., was filed with the Secretary of State of Delaware on June 6, 2006. An Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate of Incorporation"), then named Verso Paper Corp., was filed with the Secretary of State of Delaware on May 12, 2008.
