**Certificate for Amended Articles of Incorporation
of
Precision Foods, Inc.**

To The Secretary of State of The State of Iowa:

Pursuant to Section 1003 of the Iowa Business Corporation Act, as amended (the "Act"), the undersigned corporation (the "Corporation") hereby amends its Articles of Incorporation.

1. Name of Corporation. The name of the Corporation prior to this amendment of its Articles of Incorporation is "Precision Foods, Inc."
2. Text of Amended Article. The exact text of the amendment to the Corporation's Articles of Incorporation is as follows:

**ARTICLE I
NAME**

The name of the Corporation shall be **Kent Precision Foods Group, Inc.**

3. Date of Adoption. The amendment to the Corporation's Articles of Incorporation was adopted by Consent of the Corporation's Board of Directors as of November 1, 2012.
4. Shareholder Approval. The amendment to the Corporation's Articles of Incorporation was duly approved by the Corporation's shareholder in the manner required by the Act and by the Corporation's Articles of Incorporation.
