**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of January 23, 2015 ("Release"), is made by **BANK OF AMERICA, N.A.**, as administrative and collateral agent (in such capacities, the "Administrative Agent") in favor of **YALE INDUSTRIAL PRODUCTS, INC.**, a Delaware corporation the "Assignor").

WHEREAS, Assignor entered into that certain Intellectual Property Security Agreement Supplement, dated as of March 13, 1998 (as amended, the "IP Assignment") with Fleet National Bank;

WHEREAS, the IP Assignment was recorded at the United States Patent and Trademark Office ("USPTO") on May 4, 1998 at Reel 1736 Frame 0172,

WHEREAS, the IP Assignment was assigned to Fleet Capital Corporation at Reel 2620 Frame 0400 on December 3, 2002;

WHEREAS, pursuant to an assignment agreement, Bank of America, N.A. has succeeded to all rights of Fleet Capital Corporation under the IP Assignment as recorded on Reel 3135 Frame 0627 on August 5, 2005;

WHEREAS, pursuant to the IP Assignment, Assignor granted to the Administrative Agent a continuing security interest in all of the Assignor's right, title and interest in and to certain trademarks; and

WHEREAS, the Assignor has requested that the Administrative Agent release the liens and security interests granted to the Administrative Agent by the Assignor with respect to the trademarks of Assignor, including those trademarks listed on Exhibit A attached hereto ("Released Trademarks").

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent and the Assignor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the IP Assignment.

SECTION 2. Termination and Release. Administrative Agent hereby:

(a) absolutely and unconditionally cancels, discharges, and releases the collateral assignment, mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to and under the Released Trademarks listed on Schedule A attached hereto; and

(b) authorizes and requests the recordation of this Release with the USPTO.
