**TRADEMARK ASSIGNMENT**

WHEREAS, Flowerbud, LLC (“Assignor”), owns certain right, title and interest in and to the registered trademark MONTHLY SPLENDOR, United States Patent and Trademark Office Registration Number 2,395,484 (the “Mark”).
