
TRADEMARK ASSIGNMENT

The rights Assignee holds are the same as the rights that would have been held by me as Assignor if this Assignment and sale had not been made. Those rights include all claims for royalties for licensing of the Trademark and damages by reason of past infringements of the Trademark, with the right to sue for and collect the same for its own use and benefit, for the use, benefit and on behalf of its successors, assigns, and other legal representatives.
