TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is entered into as of the 2nd day of January 2015, 2014, by and between Kra-ze, LLC, a Connecticut Limited Liability Company, having an address of 32 Cedar Lane, Uncasville, Connecticut 06382 ("Assignor"), and Luxco, Inc., a Missouri corporation, having an address at 5050 Kemper Avenue, St. Louis Missouri 63139 ("Assignee").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the BOWER HILL trademark, including U.S. Patent and Trademark Office Trademark Application No. 86108152 for the mark BOWER HILL, and all goodwill associated with the foregoing (collectively, the "BOWER HILL Mark");

WHEREAS, Assignor and Assignee have entered into an Asset Purchase & Sale Agreement, ("Asset Purchase Agreement"), in which Assignor has agreed to sell and transfer to Assignee all right, title and interest in and to the BOWER HILL Mark and associated goodwill;

WHEREAS, Assignor therefore wishes to assign the entire rights, title and interest in and to the BOWER HILL Mark including the goodwill associated therewith to Assignee, and Assignee desires to accept the BOWER HILL Mark including the goodwill associated therewith.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. Assignor hereby transfers and assigns to Assignee its entire right, title and interest in and to the BOWER HILL Mark, together with the goodwill associated therewith, including without limitation, the right to sue for past infringement, and all registrations and applications therefor, including U.S. Trademark Application No. 86108152.

2. This Assignment shall inure to the benefit of, and be binding upon the parties, their successors and assigns.
