TRADEMARK ASSIGNMENT

WHEREAS, DreamHammer Products LLC, a Delaware limited liability company (“ASSIGNEE”) is a wholly-owned subsidiary of DreamHammer Incorporated, a California corporation (“ASSIGNOR”);

WHEREAS, prior to the Assignment Effective Date, ASSIGNOR owned certain trademarks and/or service marks, and applications and/or registrations for such marks, as listed in Exhibit A attached hereto and incorporated herein by this reference (“MARKS”);

WHEREAS, ASSIGNOR and ASSIGNEE entered into a certain Contribution Agreement, dated September 24, 2012 (the “**Contribution Agreement**”), assigning, among other things, all right, title and interest in and to the MARKS and in and to the registrations and/or applications for same from ASSIGNOR to ASSIGNEE as of September 24, 2012 (the “**Assignment Effective Date**”);

WHEREAS, ASSIGNEE, as of the Assignment Effective Date, acquired all of the right, title and interest of ASSIGNOR in, to and under the MARKS, together with the goodwill of the business symbolized by the MARKS; and

WHEREAS, ASSIGNOR and ASSIGNEE seek to record with the United States Patent and Trademark Office the assigning of, all right, title and interest in and to the MARKS and in and to the registrations and/or applications for same from ASSIGNOR to ASSIGNEE, as of the Assignment Effective Date.

NOW, THEREFORE, for good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, pursuant to the Contribution Agreement, as of the Assignment Effective Date ASSIGNOR sold, assigned, transferred and conveyed unto ASSIGNEE its entire right, title and interest in and to the MARKS, and to the applications and/or registrations for the MARKS, together with the goodwill of the business symbolized by the MARKS and the business of the ASSIGNOR to which the MARKS pertain, including, without limitation, all rights to apply for, file, register, maintain, extend or renew same, all rights to transfer and grant licenses and other rights with respect thereto, and all rights to enforce, and bring actions for all past, present and future infringements, misappropriations or other violations of or relating thereto and to settle, and collect and retain the proceeds from, any such actions. As of the Assignment Effective Date and pursuant to the Contribution Agreement, ASSIGNEE hereby accepted such conveyance, assignment, and transfer.

ASSIGNOR grants to ASSIGNEE and to the attorneys of record (now and in the future) for the MARKS the power to insert on this Assignment any further identification information that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office, and any foreign trademark office, for recordation of this document. ASSIGNOR agrees, at the request and expense of ASSIGNEE (but without limiting ASSIGNOR’S obligations under the Contribution Agreement in any way), to take or cause to be taken all such other actions, including the execution of any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments and other documents,


which may be reasonably required or necessary to more effectively secure to, and vest in, ASSIGNEE and its successors and assigns, the entire right, title and interest in and to the MARKS and otherwise to effectuate fully the purposes, terms and conditions of this Assignment.

This Assignment is binding upon and inures to the benefit of all of ASSIGNOR and ASSIGNEE and their respective successors and assigns. This Assignment shall be governed by the laws of the State of Delaware. In the event of a conflict between the Contribution Agreement and this Assignment, the Contribution Agreement shall govern.


