- 3. <u>Intent-to-Use Applications</u>. Seller and Buyer expressly acknowledge that with respect to certain U.S. trademark applications that these applications were filed on an "intent-to-use" basis and that in order to fully assign the rights in these applications, Seller and Buyer expressly affirm that Buyer is a successor to Seller's business to which the Trademarks pertain and that such business is ongoing and existing and that as such, this Assignment is proper under 15 USC §1060; 37 CFR §3.16, and TMEP 501.01(a).
- 4. <u>Counterparts</u>. This Assignment may be executed in one or more counterparts, each of which shall for all purposes be deemed an original and all of such counterparts, taken together, shall constitute one and the same Assignment. The exchange of copies of this Assignment and of signature pages by facsimile transmission or .PDF delivered via email will constitute effective execution and delivery of this Assignment as to the parties and may be used in lieu of the original Assignment for all purposes.




