RELEASE OF TRADEMARK SECURITY AGREEMENT

January 27, 2015

WHEREAS, EFRONT DMLT HOLDINGS, INC., a Delaware corporation ("*Acquisition Sub*"), DMLT, LLC, a New York limited liability company ("*DMLT*"), DMLT EAST, LLC, a Florida ("*DMLT East*"); Acquisition Sub, DMLT and DMLT East are, individually, a "*Grantor*", and collectively, the "*Grantors*") granted a security interest to Silicon Valley Bank, as Administrative Agent (the "*Assignee*") in and a lien upon certain trademarks as set forth in that certain Trademark Security Agreement dated October 31, 2012 by the Grantors in favor of the Assignee (the "*Original Trademark Security Agreement*"), which was recorded in the United States Patent and Trademark Office on November 1, 2012 at Reel 004892, Frame 0084;

WHEREAS, ANALYTX, INC., a Delaware corporation ("*Analytx*"; Acquisition Sub, DMLT and DMLT East are, individually, a "*Grantor*", and collectively, the "*Grantors*") granted a security interest to Assignee in and a lien upon certain trademarks as set forth in that certain First Supplement to Trademark Security Agreement dated October 22, 2013 (the "*Supplement No. 1*", and together with the Original Trademark Security Agreement, collectively, the "*Trademark Security Agreement*"), which was recorded in the United States Patent and Trademark Office on October 22, 2013 at Reel 005135, Frame 00940;

WHEREAS, the Grantors have requested that the Assignee release and reassign to Grantors their interest in the trademarks identified in Schedule A hereto and made a part hereof; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee hereby:

1. releases and reassigns to Grantors any and all liens, security interests, right, title and interest of Assignee pursuant to the Trademark Security Agreement in the trademarks identified in Schedule A and/or any goodwill associated with any of the trademarks identified in Schedule A, without recourse or representation or warranty, express or implied of any kind; and
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
