CONFIRMATORY ASSIGNMENT OF TRADEMARKS

WHEREAS, pursuant to an Asset Purchase Agreement made as of November 5, 2014 between **FEATHERLITE INDUSTRIES LIMITED** (the "**Assignor**"), Lite Ladder Corp. ("**Lite**") and Featherlite Holdings Limited, the Assignor agreed to sell, effective as of the Closing (as defined in the Asset Purchase Agreement), all of its right, title, benefit, ownership, possession, use and interest in and to the trademarks listed in Schedule A (the "**Trademarks**") to Lite;

AND WHEREAS, pursuant to an Assignment Agreement made on November 28, 2014 between Lite and **LOUISVILLE LADDER CORP.** (the "**Assignee**"), Lite assigned, transferred and conveyed all of its right, title, and interest in and to the Asset Purchase Agreement to the Assignee;

AND WHEREAS the Assignee is desirous of confirming that it has acquired the whole right, title, and interest in and to the Trademarks, together with the goodwill associated therewith;

NOW THEREFORE, in consideration of the covenants and agreements contained in the Asset Purchase Agreement and herein and such other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the Assignor confirms that it has assigned, transferred and conveyed, and, to the extent that it has not assigned, transferred and conveyed, hereby assigns, transfers and conveys to the Assignee, its successors and assigns, the whole right, title, and interest in and to the Trademarks, together with the goodwill associated therewith, and any and all rights of action accruing to the Assignor as owner of the Trademarks, including actions arising from prior infringement or other unauthorized use of the Trademarks, and any and all rights as a party in any opposition or similar proceedings, the same to be held and enjoyed as fully and exclusively as the same would have been held and enjoyed by the Assignor had this assignment, transfer and conveyance not been made.

The Assignor hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trademarks to the Assignee, and to enable the Assignee to obtain and maintain the applications and registrations for the Trademarks, all without further consideration.

The Assignor does hereby authorize any official whose duty it is to grant trademarks or related registrations, to issue registrations for any pending or yet to be filed applications for said Trademarks to the Assignee, and to the Assignee's successors, assigns, nominees or other legal representatives.

The Assignor, on behalf of itself and its successors, assigns, nominees or other legal representatives, does hereby authorize said Assignee, its successors, assigns, nominees or other legal representatives, including its Trademark Agents to amend the present assignment document to insert or correct the filing date, serial number, registration number or other identifying information as may be needed to record same.

This Assignment may be executed in as many counterparts as may be necessary, each of which so executed shall be deemed to be an original and each signed copy sent by facsimile or other means of electronic transmission producing a printed copy shall be deemed to be an original, and such counterparts together shall constitute one and the same document and notwithstanding the date of execution shall be deemed to be effective as of the date set forth above.
