TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is made as of January __, 2015, by Northwest Farm Credit Services, FLCA ("FLCA") and Northwest Farm Credit Services, PCA ("PCA") (FLCA and PCA are collectively referred to herein as the "Grantee").

WITNESSETH:

WHEREAS, FLCA and Wheat Montana Farms, Inc., Wheat-Montana Bakery, Inc., Wheat Montana Franchising, Inc. and Wheat Acquisition Company ("collectively, Grantor"), are parties to that certain Security Agreement and License of Intellectual Property (the "FLCA Agreement"), dated as of December 13, 2005, pursuant to which Grantor granted a security interest to FLCA in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to FLCA;

WHEREAS, the FLCA Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on April 26, 2006 at Reel 3298 Frame 0001;

WHEREAS, PCA and Grantor are parties to that certain Security Agreement and License of Intellectual Property (the "PCA Agreement"), dated as of December 12, 2005, pursuant to which Grantor granted a security interest to PCA in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to PCA;

WHEREAS, the PCA Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 19, 2006 at Reel 3289 Frame 0804;

WHEREAS, Grantor has requested that each Grantee release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, each Grantee has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Each Grantee hereby releases its security interest in and lien on all of Grantor's right, title and interest in the following (collectively, the "Trademark Collateral"):

(i) each trademark and trademark application, including, without limitation, each trademark and trademark application referred to in Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;

(ii) each trademark license, including, without limitation, each trademark license listed on Schedule 1 annexed hereto, together with all goodwill associated therewith; and


(iii) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1 annexed hereto, any trademark issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under any trademark license listed on Schedule 1 annexed hereto.

2. Each Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by any Grantee, all of such Grantee's right, title and interest (if any) in and to the Trademark Collateral.


