

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

At Assignee's request, Assignor will execute and deliver all papers, instruments and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all right, title and interest in and to the Trademarks, Applications and Registrations to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.

The Assignment is binding on and inures to the benefit of the Assignor and Assignee and their respective successor and assigns.
