Lender does hereby release and discharge, without representation, recourse or warranty whatsoever, its security interest in, to and under the Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto) granted to it by Grantor by way of that certain Security Agreement; which security interest is dated May 31, 2013, and was recorded June 4, 2013, at: (a) Patent Reel 030548, Frame 0079, with respect to the Patents, and (b) Patent Reel 5040, Frame 0666, with respect to the Trademarks, in the U.S. Patent and Trademark Office, to which reference may be had, the debt secured thereby having been paid and satisfied in full; and in confirmation thereof Lender does hereby transfer and assign to Grantor, without representation, recourse or warranty whatsoever, any and all right, title and interest it may have or have ever had in the Collateral.
