TRADEMARK ASSIGNMENT

WHEREAS, American Enterprises MPT L.P., a Delaware limited partnership, was the owner of certain common law rights in the trademark "CEBMAG" and the owner of record of U.S. Trademark Registration No. 1,352,456 for "CEBMAG" (collectively "Trademark");

WHEREAS American Enterprises MPT .L.P. and Formsprag LLC, , a Delaware limited liability company, are parties to an assignment of the Trademark dated April 4, 2003 and recorded at the U.S. Patent and Trademark Office at Reel/Frame number 2726/0992 and are parties to a duplicate assignment of the Trademark dated October 14, 2005 and recorded at the U.S. Patent and Trademark Office at Reel/Frame number 3209/0550 (collectively, "Assignments");

WHEREAS, American Enterprises MPT L.P. had, before execution of either of the Assignments, changed its name to Ameridrives International L.P. in accordance with a certificate of amendment dated April 25, 1997 and has since been converted to a Delaware limited liability company and changed its name to Ameridrives International LLC;

WHEREAS, the relative dates of the Assignments and the change in name of American Enterprises MPT L.P. may cause confusion regarding the chain of title regarding the Trademark; and

WHEREAS Ameridrives International LLC (f/k/a/ Ameridrives International L.P. (f/k/a American Enterprises MPT L.P.)) ("Assignor") and Formsprag LLC ("Assignee") wish to clarify the chain of title through this nun pro tunc assignment from Assignor to Assignee dated as of the April 4, 2003 date of first of the Assignments referred to hereinabove;

NOW, THEREFORE, be it known by all whom it may concern, that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

Assignor, as of April 4, 2003, hereby assigns, sells and sets over unto the Assignee, its successors, legal representatives and assigns, the entire right, title, and interest to, any and all rights and privileges associated with said Trademark together with the goodwill of the business symbolized thereby and the right to bring suit and collect damages for past infringements thereof. Assignor hereby covenants and agrees that the Assignor will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect said right, title, and interest and said rights and privileges in Assignee, its successors, assigns and legal representatives.
