**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This Termination And Release Of Security Interest In Intellectual Property ("Termination and Release") is dated as of January 30, 2015, from PNC Bank, National Association, as agent for all lenders (collectively the "Agent"), to EZ Shipper Racks, Inc., a California corporation, for itself and as successor to EZ Shipper Racks, LLC, a California limited liability company (collectively, the "Grantor").

WITNESSETH:

WHEREAS, in connection with the Revolving Credit and Security Agreement, as may have been amended, modified, supplemented, extended and/or restated from time to time (the "Credit Agreement"), entered into between the Agent and Grantor as of December 22, 2006, the Grantor executed and delivered an Intellectual Property Supplement to Revolving Credit and Security Agreement (the "IP Supplement"), dated December 22, 2006, in favor of the Agent;

WHEREAS, pursuant to the Credit Agreement and the IP Supplement, the Grantor granted security interests (the "Security Interests") to the Agent in certain Intellectual Property collateral (the "IP Collateral," as defined hereinafter); and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interests in the IP Collateral;


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Agent, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "IP Collateral," as used herein, shall mean all of the Grantors' right, title, and interest of every kind and nature as of the date hereof in any trademarks, trademark applications, service marks, trade styles, trade names, patents, patent applications, copyrights, copyright applications, domain names, and any and all goodwill associated therewith (including, without limitation, the intellectual property listed on Schedule A hereto).

2. Release of Security Interests. The Agent hereby terminates, releases and discharges in its entirety the Security Interests in the IP Collateral.
