SECOND: The Articles of Organization were filed by the Company on December 20, 2012 and assigned document number L12000159588.

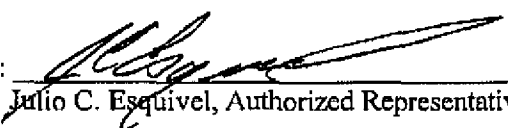
THIRD: The following amendment to the Articles of Organization has been adopted by the Company:
