**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of November 14, 2014 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of Vantage Media, LLC, a California limited liability company, VM Holdings, LLC, a Delaware limited liability company, and BrokersWeb, Inc., a Florida corporation (each a “Grantor”, and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of September 15, 2011 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) and the Intellectual Property Security Agreement dated as of September 15, 2011 (“IP Security Agreement”), each by and among the Grantors party thereto and the Administrative Agent, each Grantor granted, assigned, conveyed, mortgaged, pledged, hypothecated, and transferred a security interest in and Lien upon, and pledged and assigned to the Administrative Agent, for the benefit of the Secured Parties and the Administrative Agent, upon all of the right, title, and interest, and assets and rights, of such Grantor in the Intellectual Property Collateral, including the foregoing listed on Schedule A attached hereto;

**WHEREAS**, the IP Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on September 21, 2011 at Reel 4630 Frame 0167.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the Secured Parties and the Administrative Agent, and Grantors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Secured Parties and the Administrative Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and Lien on and security interest in and to all of the right, title, and interest, and assets and rights, of such Grantor in the Intellectual Property Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, and re-assigns back to each Grantor respectively any right, title, or interest of Administrative Agent, if any, in such Intellectual Property Collateral; and


(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Secured Parties and the Administrative Agent, has caused this Termination and Release of Security Interest in Intellectual Property to be duly executed as of the date first set forth above.
