**RELEASE AND TERMINATION OF SECURITY INTEREST

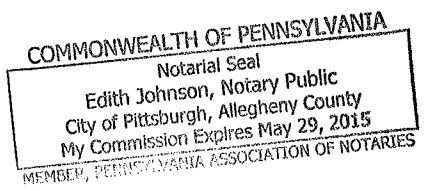
