

Pursuant to the provisions of Section 251 of the General Corporation Law of the State of Delaware (the "DGCL"), PayPal, Inc., a Delaware corporation ("PayPal"), hereby certifies the following information relating to the merger (the "Merger") of Braintree, Inc., a Delaware corporation ("Braintree"), with and into PayPal:

**FIRST:** The names and states of incorporation of the constituent corporations in the Merger are:


