## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of January 30, 2015, by GENERAL ELECTRIC CAPITAL CORPORATION (the "Secured Party").

WITNESSETH:

WHEREAS, CYCLE GEAR INC., a California corporation (the "Grantor") granted a security interest to Secured Party in certain Trademarks (as defined below) and Trademark Collateral (as defined below) pursuant to that certain Intellectual Property Security Agreement, dated as of July 14, 2000, executed by Grantor in favor of Secured Party, as security for certain obligations previously owed by Grantor to Secured Party, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, Grantor requested that Secured Party release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to such Grantor.

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) all of its Trademarks, including, without limitation, those listed on Schedule 1 hereto (collectively, the "Trademarks"); and

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest, if any, in and to the Trademarks and the Trademark Collateral.



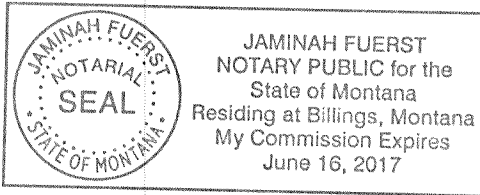
