This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of February 3, 2015, is made by Zions First National Bank, a national banking association ("Zions"), as lender ("Lender"), under the Loan Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Loan Agreement, as hereinafter defined).

**WHEREAS**, in connection with that certain Loan Agreement dated as of July 20, 2012 (together with all amendments, supplements and addenda thereto, the "Loan Agreement"), by and among Career Step, LLC and Career Step Holdings, LLC (collectively, the "Loan Parties"), and the Lender, the Lender agreed to make certain advances of money and to extend certain financial accommodation to the Loan Parties;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, relinquishes, releases and discharges, without representation, recourse or warranty whatsoever, all of its lien on and security interest in the Intellectual Property Collateral, whether granted pursuant to any agreement or document delivered in connection with the Security Agreement, and Lender hereby assigns any and all right, title and interest that Lender may have in the Intellectual Property Collateral to the Loan Parties.

Lender agrees, at the Loan Parties' sole cost and expense, to cooperate with the Loan Parties and to provide the Loan Parties with the information and additional authorization reasonably required to effect the release of the Lender's security interest in the released collateral described herein.

Lender hereby authorizes and requests that the USPTO, the Copyright Office and any other applicable government agency record this Release.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of Utah.


