REQUEST FOR CORRECTION BY DECLARATION

I, John P. Foryt, hereby declare as follows:

1. I am currently employed by Eastman Chemical Company as Senior Counsel. Prior to that, I was employed by Solutia, Inc., and was in charge of Solutia's intellectual property department in my role as Chief Intellectual Property Counsel, Solutia Inc.

2. I am familiar with U.S. Trademark Registration No. 265,127 for the mark SANTICIZER. The mark was registered on December 17, 1929, by Monsanto Chemical Works, which later changed its name to Monsanto Company. (Reel/Frame: 0112/0113.) In 1997, Monsanto Company assigned the SANTICIZER mark and registration to Solutia. (Reel/Frame: 1659/0444 and 1683/0260.)

3. In 2000, Solutia assigned the SANTICIZER mark and registration to Ferro Corporation. (Reel/Frame: 2267/0141.)

4. Three years later, Solutia entered into a security agreement with Ableco Finance LLC. Because of an administrative error, the SANTICIZER registration was included on the schedule of 250+ marks for which Solutia granted Ableco Finance a security interest. Thereafter, the security interest was erroneously recorded against the SANTICIZER registration in three filings that currently appear on the trademark assignment record for the registration in

the U.S. Patent and Trademark Office's online records. A true and correct printout of the Trademark Assignment Abstract of Title for the SANTICIZER registration (U.S. Reg. No. 265,127) is attached hereto as Exhibit A.

5. The erroneously recorded assignments are identified on the Exhibit A as Assignment Nos. 5, 6, and 7.

- a. Assignment No. 5 -- Conveyance: Assignment for Security; Assignor: Solutia Inc.; Assignee: Abelco Finance LLC, as Collateral Agent; Execution Date: 10/08/2003; Recorded: 10/09/2003; Reel/Frame: 2730/0602. A true and correct copy of the original cover sheet and underlying document, with the correction striking U.S. Reg. No. 265,127 from the schedule of marks for which a security interest was granted (which I have both initialed and dated), recorded at Reel 2730, Frame 0602 is attached hereto as Exhibit B.



6. Assignment Nos. 5, 6, and 7 are erroneous because Solutia was not the owner of the registration at the time the security interest to Ableco Finance was granted, and the inclusion of the SANTICIZER registration on the schedule for the security agreement was due to an administrative error.

7. On December 19, 2014, Ferro Corporation assigned the SANTICIZER mark and registration to Polymer Additives, Inc. (Reel/Frame: 5424/0368.) Accordingly, Polymer Additives, Inc. is the current owner of the SANTICIZER registration.

8. In view of the foregoing, I hereby request to have the references to the erroneous recording removed from the SANTICIZER registration, which is now owned by Polymer Additives, Inc.
