## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 2, 2015 (this "Release"), is made by Bank of America, N.A., as Domestic Administrative Agent for itself and for certain Secured Parties (in such capacity, the "Domestic Administrative Agent"), with respect to a Domestic Pledge and Security Agreement and a Trademark Security Agreement, both dated as of May 17, 2012 (the "Security Agreements"), between, among others, Corinthian Colleges, Inc. (the "Grantor") and the Domestic Administrative Agent. Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreements and/or a Fourth Amended and Restated Credit Agreement dated as of May 17, 2012 (collectively, the "Agreements").

### W I T N E S S E T H:

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Domestic Administrative Agent, for its benefit and for the benefit of Secured Parties identified in the Agreements, a security interest in certain of the Grantor's U.S. trademarks set forth on Schedule A hereto, including the registrations therefor and the goodwill of the Grantor's business symbolized thereby and related trademark collateral identified in Section 2 of the Trademark Security Agreement (the "Trademark Collateral"); and

WHEREAS, the Domestic Administrative Agent, for itself and on behalf of the Secured Parties, wishes to: (i) release the Domestic Administrative Agent's and Secured Parties' security interest covering the Trademark Collateral; (ii) restore all right, title and interest in and to the Trademark Collateral to the Grantor; and (iii) dissolve any and all liens and encumbrances with respect to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Domestic Administrative Agent does for itself and for each of the Secured Parties agree as follows:

1. Release of Lien. The Domestic Administrative Agent does for itself and for Secured Parties hereby unconditionally, irrevocably and absolutely terminate, extinguish, cancel, release and forever discharge the security interest and any of its and the Secured Parties' right, title and interest in or to the Trademark Collateral, whether granted pursuant to the Agreements or any other agreement or document delivered in connection with the Agreements. For the avoidance of doubt, this Release does not pertain to any trademarks other than those set forth on Schedule A and, in particular, does not pertain to any Canadian trademark registrations or any trademarks owned by Heald College, LLC.

2. Authorization to Record. The Domestic Administrative Agent hereby authorizes Grantor or Grantor's authorized representative to record this Release with the USPTO. This Release may, in particular, be recorded with the USPTO to reflect the release of the Security Agreement, which was recorded with the USPTO on May 25, 2012, at Trademark Reel 004788, Frame 0491.

3. Further Assurances. The Domestic Administrative Agent agrees to cooperate with the Grantor and Grantor's successors and assigns and to provide the Grantor and its successors and assigns with such information and additional authorizations and to execute and deliver to Grantor and its successors and assigns such additional instruments and to take such action, in each case, as may be reasonably requested or as may be desirable to effect and record this Release.

IN WITNESS WHEREOF, the Domestic Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the day and year first above written.
