FULL RELEASE OF SECURITY AGREEMENT

THIS FULL RELEASE OF SECURITY AGREEMENT (this "Release") is made and entered into this 5th day of February, 2015, by U.S. BANK NATIONAL ASSOCIATION ("Lender"), in favor of Charter NEX Films, Inc., a Wisconsin corporation ("Borrower").
