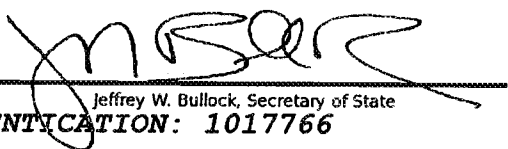

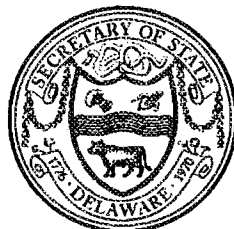

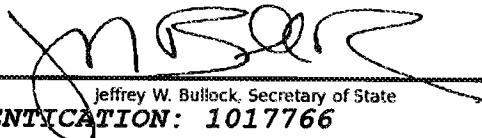

Pursuant to the provisions of Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned entity adopts the following Certificate of Merger for the purpose of effecting the merger (the "Merger") of Frank's Casing Crew & Rental Tools, LLC, a Louisiana limited liability company ("Frank's Casing"), Frank's Tong Service, LLC, an Oklahoma limited liability company ("Frank's Tong"), High Tech Components, LLC, a Louisiana limited liability company ("High Tech"), Oilfield Services, LLC, a Delaware limited liability company ("Oilfield") and Frank's Westates Services, LLC, a Delaware limited liability company ("Frank's Westates" and, collectively with Frank's Casing, Frank's Tong, High Tech and Oilfield, the "Merged Entities" and each a "Merged Entity"), with and into Frank's International, LLC, a Texas limited liability company ("Frank's International"), with Frank's International to continue in existence following the Merger as the surviving company. Frank's International does hereby certify for the purpose of merging the Merged Entities with and into Frank's International each of the following:

1. The name and state of formation of each of the constituent entities of the Merger are as follows:

6. A copy of the Agreement and Plan of Merger will be furnished by the surviving limited liability company on request, without cost, to any member of the constituent entities.

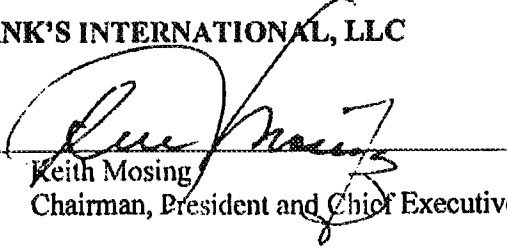
