ASSIGNOR hereby covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict with this Assignment;

ASSIGNOR hereby further covenants and agrees that it will communicate to ASSIGNEE any and all facts known to it respecting said U.S. trademark registrations and U.S. pending trademarks, and, at ASSIGNEE'S expense, testify in any legal proceeding, sign all lawful papers, execute and deliver all papers and take any actions that may be necessary and desirable to perfect the title to any aforementioned trademark registrations and pending trademarks, and make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper trademark protection for said trademarks in all countries.


