## **ASSIGNMENT OF SECURITY INTEREST IN CERTAIN TRADEMARKS**

This ASSIGNMENT OF SECURITY INTEREST IN CERTAIN TRADEMARKS (this "Assignment") is made as of February 10, 2015, by and between GARMARK PARTNERS II, L.P., a Delaware limited partnership (the "Existing Lender"), and SCP DISTRIBUTORS LLC, a Delaware limited liability company (the "Successor Lender").

### PRELIMINARY STATEMENT

A. NAMCO, LLC, a Delaware limited liability company ("Grantor"), granted to the Existing Lender, as lender under the Financing Arrangement described below, a security interest in, among other assets, all of its registered trademarks described in that certain Trademark Security Agreement, dated as of August 20, 2013 (the "Trademark Security Agreement"), by and between Grantor and Rockland Trust Company, a Massachusetts trust company (as predecessor to Existing Lender) ("Rockland"), for which the registered trademarks are set forth in Exhibit A attached hereto (the "Trademark Collateral").

B. Such security interest was granted to secure certain financing arrangements provided to Grantor under a revolving credit agreement extended by the Existing Lender (the "Financing Arrangement").

C. The Trademark Security Agreement and such security interest in the Trademark Collateral was recorded on September 23, 2013, with the United States Patent and Trademark Office (the "USPTO") at Reel 5115, Frame 0886. The assignment by Rockland to Existing Lender of the Trademark Security Agreement and such security interest in the Trademark Collateral was recorded on March 11, 2014 with the USPTO at Reel 5235, Frame 0357.

D. The Existing Lender assigned its obligations as lender with respect to the Financing Arrangement to the Successor Lender. The parties hereto desire to assign the Trademark Security Agreement and the security interest granted to the Existing Lender to Successor Lender thereunder and to provide evidence of such assignment in a form capable of recordation with the USPTO.

In consideration of the premises set forth herein and for other good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. The Existing Lender, in its capacity as lender, hereby assigns and conveys, without representation, warranty or recourse, the Trademark Security Agreement and all of its security interest in, to and under the Trademark Collateral to Successor Lender, in its capacity as lender.

2. This Assignment of Security Interests in Certain Trademarks shall be governed by and construed and enforced in accordance with the laws of the State of New York.





