ARTICLE ONE

A plan of conversion has been adopted and approved by the Converting Entity in accordance with the provisions of Section 10.101 of the Texas Business Organizations Code.

The plan of conversion sets forth that the name of the Converting Entity is Source Network Sales and Marketing, Inc., that the Converting Entity was formed in the State of Texas as a corporation under the Texas Business Organizations Code, and that the Converting Entity is being converted from a corporation to a limited liability company to be formed in the State of Texas under the Texas Business Organizations Code and to be known as "Source Network Sales and Marketing, LLC" in accordance with the Texas Business Organizations Code, with the Certificate of Formation for such entity attached hereto as Exhibit A.




