TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is made and entered into as of the 30 day of January, 2015, by Mohawk Carpet Distribution, Inc., a company duly organized and existing under the laws of the state of Delaware, having a mailing address at P.O. Box 12069, Calhoun, Georgia 30701 ("Assignor") and Homer TLC, Inc., a Delaware corporation having its principal place of business at 1007 Orange Street, Nemours Building, Suite 1424, Wilmington, Delaware 19801 ("Assignee"). The parties agree as follows:

WITNESSETH:

WHEREAS, Assignor desires to assign to Assignee all of Assignor's worldwide right, title, and interest in and to the "LIFEPROOF CARPET" mark (the "Mark"), together with the goodwill of the business associated therewith, and any applications or registrations thereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby grant, assign, and convey to Assignee all of Assignor's worldwide right, title, and interest in and to the Mark, to include, but not limited to, U.S. Trademark Serial No. 85663602, with the goodwill of the business symbolized by the Mark, including, without limitation, Assignor's right, title, and interest in and to (1) the right to sue for past, present, and future infringements of the Mark; (2) all damages and payments for past or future infringements thereof; (3) the right to secure registrations for the Mark; and (4) the right to secure all renewals for any registration of the Mark. Assignor shall execute such further documentation as Assignee may request in order to establish and secure worldwide rights in and to the Mark. Assignor further acknowledges that any and all use of the trademark "MOHAWK LIFEPROOF CARPET" is confusingly similar with the Mark. Assignor agrees that it will refrain from any and all use of the MOHAWK LIFEPROOF CARPET mark and will abandon U.S. Trademark Serial No. 85663714.
