ASSIGNMENT OF TRADEMARK RIGHTS

THIS ASSIGNMENT OF TRADEMARK RIGHTS (the "Agreement") is made by and between **VideoIQ, Inc.** ("Assignor"), a Delaware corporation, and **AVO USA Holding 2 Corporation**, a Delaware corporation ("Assignee"), effective as of December 31, 2014.

RECITALS:

WHEREAS, Assignor and Assignee are parties to that certain Bill of Sale and Assumption Agreement effective as of December 31, 2014, ("**Agreement**"), pursuant to which Assignor agreed to transfer all of its trademark rights, and

WHEREAS, Assignor wishes to transfer to Assignee, and Assignee wishes to acquire from Assignor all of Assignor's right, title and interest in, to and under the trademark identified on Schedule A ("**PRAAS PREVENTION AS A SERVICE**" or "the "**Trademark**"), together with all rights that Assignor may have in such Trademark.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby grants, transfers and assigns unto Assignee and its transferees, successors and assigns:

All of Assignor's right, title and interest in and to the Trademark, the same to be held and enjoyed by Assignee as fully and entirely as they would have been held by Assignor had the assignment not been made, whether or not the same has been registered prior to, on or after the date of this Agreement, and any and all renewals and extensions thereof (or any legal equivalent thereof in a foreign country) for the full term or terms for which the same may be granted, together with the goodwill of the business carried on in connection with such trademark; and

All claims, demands and rights of action, both statutory and based upon common law, that Assignor has or might have by reason of any infringement of the Trademark prior to, on or after the date of this Agreement, together with the right to prosecute such claims, demands and rights of action in Assignee's own name; and


Any income, fees, royalties, damages and payments now or hereafter due and/or payable under and with respect to the Trademark, including without limitation, the right to recover for past, present or future infringements of the Trademark or unauthorized use.

This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective transferees, successors and assigns.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States in respect to registered Trademark issues and in all other respects by the laws of the State of Delaware, without giving effect to the conflict of laws rules thereof.


