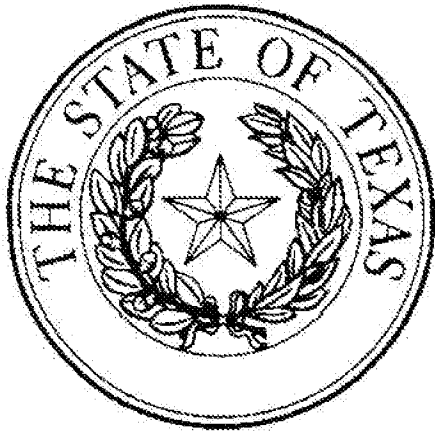

Pursuant to Chapter 10 of the Texas Business Organizations Code, as amended, and the applicable provisions of the Texas Revised Limited Partnership Act, as amended, the undersigned converting entity adopts this Certificate of Conversion.

ARTICLE I.

The name of the converting limited partnership is: SAFETY VISION, L.P. (the "Limited Partnership").

ARTICLE II.

The jurisdiction of formation of the Limited Partnership is: Texas.

ARTICLE III.

The date of formation of the Limited Partnership is: February 5, 1993.

ARTICLE IV.

ARTICLE VIII.

The plan of conversion has been approved as required by the laws of the jurisdiction of formation and the governing documents of the converting entity. All of the issued and outstanding partnership interests of the converting entity have voted for and approved the Plan of Conversion.

ARTICLE IX.

In lieu of providing a tax certificate for the converting entity, the converted entity will be responsible for the payment of all fees and taxes required by law in connection with the conversion, and will be obligated to pay such fees and taxes if the same are not timely paid.

ARTICLE X.


