## NUNC PRO TUNC ASSIGNMENT

This Nunc Pro Tunc Assignment (“Assignment”) shall be effective as of this the 21st day of March, 2013.

WHEREAS, LWFP, LLC, a company organized and existing under the laws of Delaware, having a place of business at 2525 N. NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged and accepted, Assignor does hereby irrevocably assign, transfer, grant, set over, and convey unto Assignee, its successors and assigns, *nunc pro tunc*, as of March 21, 2013, without reservation of any rights, title or interest, Assignor’s entire worldwide and universal rights, title and interest in and to the Mark, including, but not limited to, the trademark applications and registrations therefor, including those identified in Schedule A attached hereto, together with the goodwill of the business symbolized by the Mark, the same to be held and enjoyed by Assignee, for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, subsidiaries, affiliates or other legal representatives, as the same would have been held and enjoyed by Assignor if this Assignment had not been made, including, but not limited to, all common-law rights of Assignor in and/or to the Mark owned by Assignor, and Assignor’s right to sue for all claims, demands and/or causes for action, both at law and in equity, that Assignor may have on account of any infringement, claim of unfair competition, misappropriation, likelihood of confusion or dilution of the Mark or any other claim or cause of action related to the Mark prior to and following the effective date of this Assignment throughout the world. For the sake of clarity, Assignor further assigns to Assignee the right to sue and recover damages and/or profits for claims of past, present and future infringement, unfair competition, misappropriation, likelihood of confusion and/or dilution of the Mark, if any, for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives.
