IN WITNESS WHEREOF, the Assignor has caused the execution of this Assignment effective as of the 16th day of FEBRUARY, 2015.

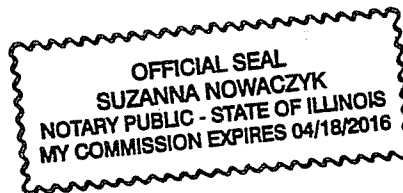
