SECOND SUPPLEMENT TO GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS

This Second Supplement to Grant of Security Interest in United States Trademarks (this “Supplement”) is made as of the 6th day of February, 2015 by each of **TAP WORLDWIDE, LLC**, a Delaware limited liability company (“TAP Worldwide”), and **TAP MANUFACTURING, LLC**, a Delaware limited liability company (“TAP Manufacturing”) (TAP Worldwide and TAP Manufacturing are hereinafter referred to, individually, as a “Grantor” and, collectively, as the “Grantors”) in favor of **ORIX CORPORATE CAPITAL INC.**, as Administrative Agent and Collateral Agent (the “Grantee”).

WHEREAS, the Grantors executed and delivered a Grant of Security Interest in United States Trademarks dated July 20, 2011 and recorded with the United States Patent and Trademark Office (the “USPTO”) on July 22, 2011 at Reel 4588, Frame 0919 (as amended of record from time to time, hereinafter, the “Grant”) in favor of the Grantee, pursuant to which the Grantors pledged, assigned and granted a security interest in certain Marks (as defined therein);

WHEREAS, the Grantors executed and delivered a First Supplement to Grant of Security Interest in United States Trademarks dated September 30, 2014 and recorded with the USPTO on October 2, 2014 at Reel 5372, Frame 0257 in favor of the Grantee, pursuant to which the Grantors pledged, assigned and granted a security interest in certain Marks; and

WHEREAS, the Tap Manufacturing has acquired an additional Mark and desires to hereby confirm the pledge of, and the grant of a security interest in, the additional Mark in favor of the Grantee.


NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect. The Grantors hereby ratify, confirm and reaffirm all of the representations, warranties and covenants contained therein.
 - b. This Supplement and the Grant cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.


