## ASSET PURCHASE AGREEMENT

This Asset Purchase Agreement (this "Agreement"), dated as of April 26, 2013, is entered into between Prestek, Inc. ("Seller"), with principal offices located at 55 Executive Drive, Hudson, NH 03051, and Mark Andy, Inc. ("Buyer"), with principal offices located at 18081 Chesterfield Airport Road, Chesterfield, MO 63005.

### RECITALS

WHEREAS, Seller is engaged in the design, manufacture, sales and service of high-technology patented digital imaging systems, patented printing plate technologies and traditional, analog systems and related equipment and supplies/consumables products for the global graphic arts and printing industries;

WHEREAS, Seller desires to sell its supplies/consumable products for use in the global graphic arts and printing industries (the "Business"); and

WHEREAS, Seller wishes to sell and assign to Buyer, and Buyer wishes to purchase and assume from Seller, substantially all the assets and liabilities of the Business, subject to the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

### ARTICLE I PURCHASE AND SALE

**Section 1.01. Purchase and Sale of Assets.** Subject to the terms and conditions set forth herein, Seller hereby agrees to sell, assign, transfer, convey and deliver to Buyer, and Buyer shall purchase from Seller, all of Seller's right, title and interest in, to and under the following assets, properties and rights of Seller, to the extent that such assets, properties and rights exist as of the Closing Date and exclusively relate to the Business (collectively, the "Purchased Assets");
