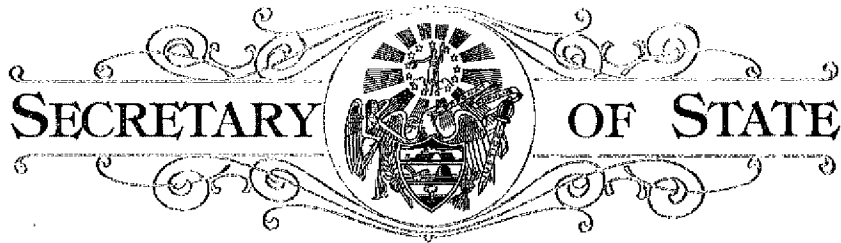

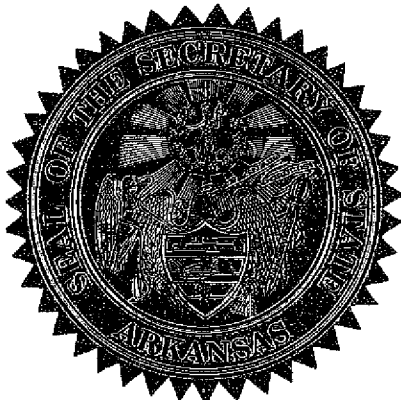

ARTICLES OF MERGER

3. CCF Brands LLC shall be the surviving entity upon completion of the merger.


4. The merger shall be effective as of December 31, 2014.
