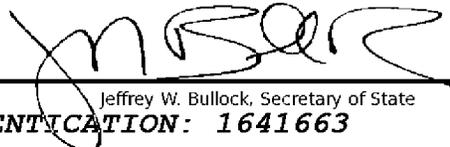

1. The name and state of domicile of each of the constituent entities to the merger (the "Merger") is as follows:

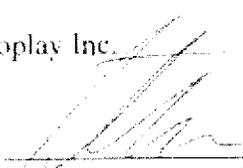
Ottoplay Inc., a Delaware corporation (the "Surviving Corporation"); and
