WHEREAS, KVOA Communications, Inc., an Arizona corporation ("Assignor"), with its principal offices at 134 Columbus Street, Charleston, South Carolina 29403-4800 adopted, used and owned the KAJA TV trademark and corresponding United States trademark registration (U.S. Trademark Reg. No. 1850910);


WHEREAS, KRIS Communications, LLC ("Assignee"), a South Carolina limited liability company with its principal offices at 134 Columbus Street, Charleston, South Carolina 29403-4800, entered into an Asset Purchase Agreement with the successor-in-interest of Assignor, KVOA Communications, LLC, a South Carolina limited liability company on September 3, 2014 under which Assignee acquired all of Assignor's right, title and interest in and to Assignor's KAJA TV trademark;

WHEREAS, it was the intention of the Assignor's successor-in-interest to convey all right, title, and interest in and to the KAJA TV trademark, together with the goodwill of the business symbolized by the mark, as part of the Asset Purchase Agreement;


WHEREAS, the conveyance of the right, title, and interest in and to the KAJA TV trademark to the Assignee was not memorialized in writing as part of the Asset Purchase Agreement;

NOW THEREFORE, this nunc pro tunc assignment is being executed by the Assignor's successor-in-interest, KVOA Communications, LLC and Assignee in order to clarify the ownership of the KAJA TV trademark, and to confirm that Assignor did assign unto the Assignee all rights, title, and interest in and to the KAJA TV trademark, including U.S. Trademark Reg. No. 1850910, together with the goodwill of the business symbolized by the mark as part of the Asset Purchase Agreement.
