**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK ("Termination") is executed and delivered as of the 24 day of February, 2015 by SunTrust Banks, Inc. (the "Secured Party"), to Accord Industries, LLC (the "Company").

**BACKGROUND**

A. On October 31, 1990, the Company, formerly known as Accord Industries Company, and the Secured Party, formerly known as Sun Bank, National Association, executed a "Security Agreement (Trademarks)" (the "Security Agreement").

B. Pursuant to the Security Agreement, the Company granted to the Secured Party a security interest in the trademark **UNIVERSAL 100** and U.S. Reg. No. 1,052,805 (the "Security Interest").

C. The Security Interest was recorded in the United States Patent and Trademark Office ("USPTO") at Reel/Frame 0752/0255 on November 19, 1990.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. The Secured Party, effective as of the date of the full repayment of the loan, terminates and releases all of its rights, title and interest in the trademark **UNIVERSAL 100** and U.S. Reg. No. 1,052,805.
2. The Company, or its designee, may record this Termination in the USPTO and in any other trademark offices as necessary to carry out the intentions of this Termination.
3. The Secured Party agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, to carry out the intentions of this Termination.
