RESOLVED that this Corporation assume all of the obligations of Netsmart Ohio, Inc.

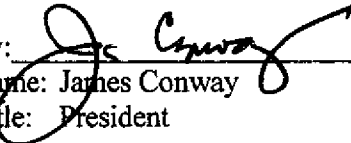
