RELEASE OF TRADEMARK SECURITY INTERESTS

WHEREAS, SunTrust Bank, a Georgia Banking Corporation (together with its successors and assigns, the "Administrative Agent"), with a principal place of business at 3333 Peachtree Road, Atlanta, Georgia 30327 was designated as the Administrative Agent pursuant to a certain Credit Agreement dated October 3, 2012 by and among Acorn Media Group, Inc. The Administrative Agent has no remaining interest whatsoever under the Security Agreements either in the trademarks or trademark licenses shown on Schedule A, or in any other registered or unregistered trademarks now owned or formerly owned by Grantor.

The Administrative Agent hereby consents that a copy of this Release of Trademark Security Interests shall be deemed a full legal and formal equivalent of any like document that may be required in any country for any purpose.
