RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “*Release*”) is made this 20th day of February, 2015, by ESCALATE CAPITAL PARTNERS SBIC I, L.P., a Delaware limited partnership (together with its successors and assigns, “*Lender*”).

WHEREAS, reference is made to a certain Intellectual Property Security Agreement dated September 10, 2014, by and between Kareo, Inc., a California corporation, CareTools, Inc., a California corporation, and Ecco Health, LLC, a Nevada limited liability company, (collectively, “*Borrowers*”) and Lender (the “*Intellectual Property Security Agreement*”); all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in such Intellectual Property Security Agreement; and

WHEREAS, under the Intellectual Property Security Agreement, Borrowers granted Lender a continuing security interest in all of the right, title and interest of Borrowers in and to the intellectual property collateral identified therein (the “*IP Collateral*”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the IP Collateral arising under the Intellectual Property Security Agreement, including, without limitation, the intellectual property described in Schedules A, B, and C hereto. Further, Lender understands and agrees that this Release may be recorded by or for Borrowers with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Lender also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Borrowers may reasonably require to affect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.
