RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release") is made as of February 27, 2015, by **BNP PARIBAS**, as collateral agent for the Secured Parties (as defined in the Trademark Security Agreement referred to herein) and having a business address at 787 Seventh Avenue, New York, New York 10019 (the "Collateral Agent"), in favor of **MIDWEST UNDERGROUND TECHNOLOGY, INC.**, an Illinois corporation, having a business address at 2626 Midwest Ct., Champaign, Illinois 61822 (the "Grantor").

W I T N E S S E T H

WHEREAS, the Collateral Agent and the Grantor are parties to a certain Intellectual Property Security Agreement, dated as of June 28, 2013 (the "Trademark Security Agreement"), wherein Grantor granted the Collateral Agent a security interest in and to the Intellectual Property Collateral (as defined in the Trademark Security Agreement), including the registered U.S. trademarks and applications identified on Schedule A attached hereto (such registered trademarks and applications and all extensions and renewals thereof, together with all goodwill of the business associated therewith and symbolized thereby, and the right to sue for past, present and future infringements and dilutions, and all rights corresponding thereto, and all income, fees, royalties, proceeds and other payments at any time due or payable with respect thereto, the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office on July 1, 2013 at Reel 5060, Frame 0858;

WHEREAS, the Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Collateral Agent, on behalf of itself and the Secured Parties, desires to grant to the Grantor a specific release of the security interest granted and recorded against each Trademark.


NOW THEREFORE, for good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, does hereby terminate the Trademark Security Agreement and assign, terminate, release and discharge the entirety of the security interest in the Trademarks and reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademarks and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish, confirm, effectuate and record this Release and the Grantor's right, title and interest in and to the Trademarks.
