1. Article I. of the Articles of Incorporation is amended to read as follows:

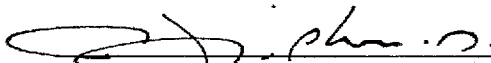
"The name of the corporation is: NEXDERM, INC."
