ASSIGNMENT OF TRADEMARKS, DOMAIN NAMES, AND COPYRIGHTS

This Assignment Agreement is made by Tarpon Biosystems Inc., a Delaware corporation (“*Assignor*”), and Pall Corporation, a New York corporation (“*Assignee*”) with reference to the following:

A. On or about January 29, 2015 Assignor together with its related entity Tarpon Biosystems Europe B.V.(collectively “*Tarpon*”) and Assignee together with its related entity Pall Technology UK Ltd. (collectively “*Pall*”) entered into an Asset Purchase Agreement (the “*APA*”) under which Pall acquired the Purchased Intellectual Property of Tarpon, as defined therein.

B. Assignor is the owner of the trademarks identified in the attached Schedule A (the “*Marks*”), registrations therefor, and the goodwill associated therewith.

C. Due to a clerical error, Assignor’s entity in the registration for the mark BIOSMB, U.S. Reg. No. 4127572 was entered incorrectly as a Massachusetts corporation rather than a Delaware corporation, and at no time did such a Massachusetts entity exist.

D. Assignor is the owner of the domain names identified in the attached Schedule A (the “*Domain Names*”).

E. Assignor is the owner of certain unregistered copyrights in works used held or used by Assignor in the conduct of the Business, as defined in the APA (the “*Copyrights*”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee all its right, title and interest in and to the Marks, Domain Names, and Copyrights, together with the goodwill of the business symbolized by the Marks, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by assignor if this assignment and sale had not been made.




