interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

The Assignor authorizes the United States Patent and Trademark Office and any other applicable jurisdictions outside the United States to record the transfer of the registration and/or registration application set forth above to Assignee as recipient of Assignors entire right, title and interest therein.

Assignor further agrees to upon the request and at the expense of Assignee: (a) that he will not assist others in challenging the assigned rights; (b) execute, verify, acknowledge and deliver all such further papers, including instruments of transfer; and (c) perform such other acts as Assignee lawfully may request to assign the Trademark.

2. WARRANTY.

Assignor warrants that Assignor is the legal owner of all right, title and interest in the Trademark, that the Trademark have not been previously pledged, assigned, or encumbered and that this Assignment does not infringe on the rights of any person.

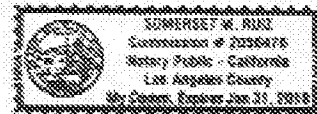
