TRADEMARK ASSIGNMENT

WHEREAS, TDBBS, INC. WHEREAS, in accordance with Section 8 (Further Assurances) of the Contribution Agreement, ASSIGNOR and ASSIGNEE wish to execute this Trademark Assignment to carry out the purposes of the Contribution Agreement and transfer the entire right, title and interest in and to the TRADEMARKS and the goodwill symbolized by the TRADEMARKS from ASSIGNOR to ASSIGNEE.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE, the entire right, title and interest in and to the TRADEMARKS in all countries worldwide, all common law rights and all rights conferred by virtue of the federal TRADEMARKS registrations, together with the goodwill of the business symbolized by the TRADEMARKS, the right to claim priority rights deriving from the TRADEMARKS by virtue of international convention, treaty or otherwise, and the right to sue for and collect damages by reason of past infringements of the TRADEMARKS.
